### **Position description**

The Department of Medicine of McGill University invites applications for a full-time Clinician-Scientist, Clinician-Investigator, Clinician-Teacher or Clinician-Educator at the rank of Assistant or Associate Professor. The candidate will also be appointed to clinical practice in the Department of Medicine, Division of Nephrology at the McGill University Health Centre (MUHC). This is a Contract Academic Staff position and does not confer eligibility for tenure.

The successful candidate is expected to have a record of scholarly accomplishment in one or more of the following areas: research (clinical or fundamental), education, or quality assurance. Eligible clinician-scientists are encouraged to simultaneously apply for and be considered for the Catherine McLaughlin Hakim Chair in Medicine, although this is not required.

The Nephrology Division provides services in general nephrology consultations, dialysis (In-centre and home dialysis), and kidney transplantation at the MUHC. We also provide renal care and dialysis to the Cree populations of northern Quebec. The candidate will join the Nephrology group at the MUHC, which consists of 16 full-time academic nephrologists and a medical scientist.

The Department of Medicine is a leader in academic medicine, and our educational and research missions support excellent and innovative clinical programs across our teaching hospitals. The MUHC is one of McGill's major teaching hospitals affiliated with the Faculty of Medicine and Health Sciences at Canada's internationally renowned McGill University, located in the vibrant and multicultural city of Montreal, in the province of Quebec.

### **Job Duties**

As a Clinician-Scientist, the candidate will be expected to develop and maintain an independent and productive research program. The research program is expected to attract external peer reviewed funding (e.g. Canadian Institutes of Health Research and the Fonds de Recherche Québec—Santé). Internal startup funding, including a research stipend for protected research time and operating funds, may be available on a competitive basis to a suitable candidate.

As a Clinician-Investigator with a focus on Quality Improvement you will focus on scholarly quality improvement activities of sufficient caliber to publish in peer-reviewed journals.

As a Clinician-Teacher, your major non-clinical focus will be on teaching the next generation of physicians. Teaching activity will include both didactic and clinical teaching.

As a Clinician-Educator, you will focus on education research of sufficient caliber to publish in peer-reviewed journals or education administration with a focus on leading/developing world class training programs.

Clinical responsibilities will include covering the nephrology consult services, dialysis units, general nephrology and transplantation outpatient clinics, and on-call duties.

The candidate is expected to be actively involved in all aspects of McGill's academic mission (teaching and supervision of clinical trainees, and involvement in academic, research and administrative activities) McGill faculty members are expected to contribute to service activities within their units, the University, and the wider scholarly community. A demonstrated commitment to equity, diversity, and inclusion is also expected.

## **Qualifications and Education requirements**

Candidates must:

- Hold an MD degree, and have completed subspecialty training in Nephrology;
- Be certified by the Royal College of Physicians and Surgeons of Canada (or equivalent); and be eligible for licensure in Quebec and certification by the Collège des médecins du Québec;
- Have completed appropriate training in clinical research, education, or quality assurance, and have experience in one of these areas;
- Have training and experience in managing all aspects of clinical nephrology;
- Have exemplary teaching skills;
- Be fluent in English and have a working knowledge of French;
- Have a demonstrated commitment to patient care supported by excellent references.

Candidates with a strong track record of peer-reviewed publications will be given preference. Procedural skills are an asset.
